4. The Exhibitor warrants that the exhibit(s) entered for competition is/are and will remain the property of the Exhibitor whilst the exhibit(s) is/are in the possession of the Society.

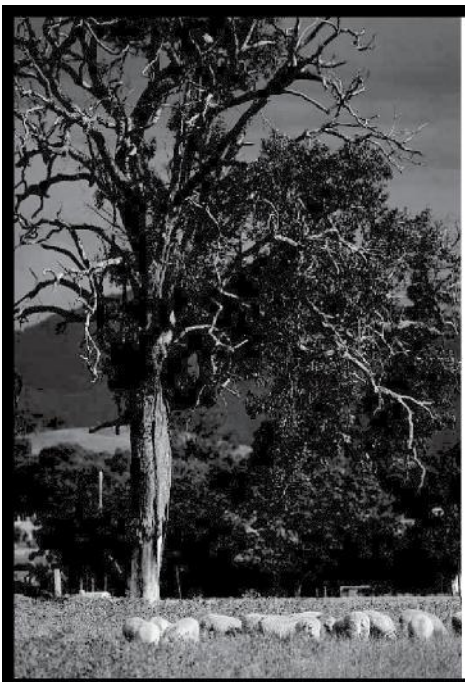

The Exhibitor acknowledges that the exhibit(s) is/are accepted and held by the Society at the risk of the Exhibitor and the Exhibitor releases the Society, its officer, members, servants and agents, from any claims, demands, actions, suits, judgements, and accounts whatsoever in respect of any injury, loss or damage occasioned to any exhibit arising out of any act or omission of the Society, its officers, members, servants, or agents, or any member of the public whilst the exhibit is in the possession of the Society and whether or not such injury loss or damage is caused or contributed to by the negligence of the Society, its officers, members, servants or agents.
